



The subject referral received consideration by the City Plan Commission at a meeting held on Tuesday, June 9, 1959.

This referral is a request to abandon a portion of Dove Street from a point 52.01 feet north of John Street northerly to Williams Street.

On an inspection survey it was found that the area in question is unpaved and uncurbed, also in evidence on the northeasterly curb line within the site area is a utility light.

Dove Street from John Street to the section included in the petition has been recently surfaced and it is unlikely that the remaining portion will be paved, also the abandonment of this portion of the street will not conflict with any present or contemplated City plans. Therefore,




Gentlemen:

As a part of the West River redevelopment area plans, Charles Street is being widened between Conanicut Street and the Charles Street Railroad Bridge.

As a part of this planning, it was proposed that the one-way portion of Charles Street, which now extends from the intersection of Charles Street and Chalkstone Avenue to Conanicut Street, be extended in the northerly direction from Conanicut Street to Ashburton Street, and that Ashburton Street be made one way southerly from Charles Street to Chalkstone Avenue. The remaining section of Chalkstone Avenue is already one way from Ashburton Street to Joseph Edward Szarko Memorial Square.

The widening project is now under way, and it is therefore recommended that the appropriate resolutions be passed by the City Council to permit the establishment of these two one-way streets.

WHEREAS, a temporary stenographic assignment in the City Clerk's Office, begun in 1909, was the first wrung on the ladder of accomplishment which Frank, as he is popularly known, has climbed during the past fifty years. From 1909 to 1926 he was employed in the City Clerk's Department as Assistant Clerk of Committees, Official Stenographic Reporter, Second Deputy City Clerk and First Deputy City Clerk. While in the Clerk's Office he studied Law and was admitted to the R. I. Bar in 1924. In January of 1926 he entered the Law Dept. where he has since served with honor and distinction. On leave of absence from July 1950 to July 1955, Mr. McManus, as special counsel, handled all of the land condemnation matters in connection with the building of the Dennis J. Roberts Expressway. His simplicity, humility and friendliness endeared him to all with whom he came in contact. His meticulous work and his vast knowledge of municipal matters were ever available to his associates in city government. His 50 year record of accomplishment is an enviable one and could well be emulated by all city employees to the betterment of the city and its people.
