






Dear Mr. Clementi,

Six months ago I was hired as a Providence Firefighter. I agreed to move to the city as part of the residency ordinance. I have been actively seeking a home in the city for the past several months. I have not had an luck in locating an affordable yet suitable home for myself and my family. Up until Wed. Jan.30,02 I thought I had found a house, the offer on the house was accepted by the seller, financing was approved, and the purchase and sales agreement was signed by me. When the seller went to sign the agreement he notified his agent that he could not move for a minimum of four months. This demand was unacceptable to me because of the residency deadline and the fact that my financing is locked until 3/11/02. In other words the deal fell through.

I am still aggressively trying to locate an appropriate home and fully intend on moving into the city. My agent is JoAnn Samborsky of Keller Williams, My financing for a new home is still set all I need is the house.

I would greatly appreciate consideration for an extension to the residency ordinance. I am fully confident that I can have this resolved in the next few months with the resources I am using.


