AN ORDINANCE AMENDING SECTIONS 16-92(j) AND 16-106 OF ARTICLE III, OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: "NOISE CONTROL".

Approved January 10, 1992

Be it ordained by the City of Providence:

SECTION 1. Section 16-92(j) of the Code of Ordinances is hereby amended as follows:

"Sec. 16-92. Definitions (j) Sound truck: shall mean any motor vehicle or any other vehicle regardless of motive power, whether in motion or stationary, having mounted thereon or therein, or attached thereto any sound amplifying equipment."

SECTION 2. Section 16-106 of the Code of Ordinances is hereby amended as follows:

"Sec. 16-106. Violations-Penalty. Any person found guilty of violating, disobeying, neglecting, or refusing to comply with the provisions of this article, shall upon conviction be punished by a fine of not more than five hundred dollars (\$500.00) or by imprisonment for a period not exceeding ten (10) days, or both, for any one offense, pursuant to Section 1-10 of the Code of Ordinances of the City of Providence, except that any person electing to appear before the clerk of Municipal Court and admitting the violation charged, or in lieu of personally appearing before the clerk of the court, electing to admit the violation by mail to the clerk of court, shall be punished by a fine of one hundred dollars (\$100.00).

SECTION 3. This Ordinance shall take effect upon its passage.
