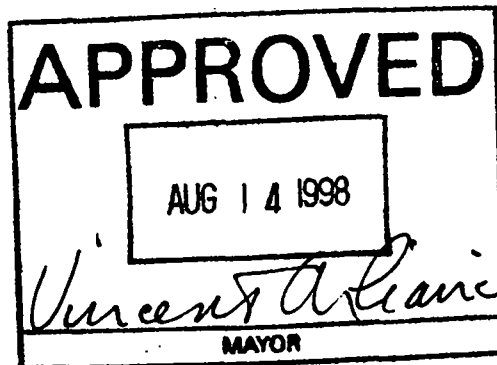

August 23, 1998	Close off Hillhurst Avenue for Local Access Only from 2:00 o'clock p.m. to 11:00 o'clock p.m.

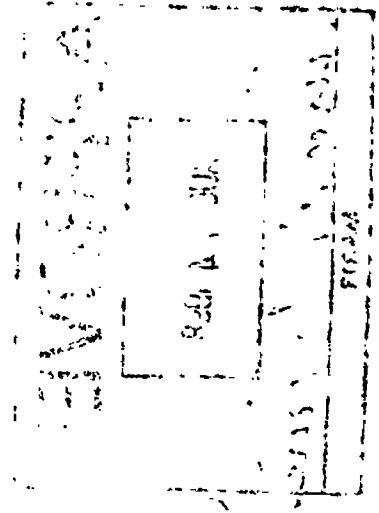
