ORDINANCE(S) SECOND READING

An Ordinance in Amendment of Chapter 16, "Offenses and Miscellaneous Provisions", Article 1, "In General", Section 16-21 "Loud or Unruly Gatherings - Public Nuisance" of the Code of Ordinances of the City of Providence.

SECTION 1. Chapter 16, "Offenses and Miscellaneous Provisions", Article I, "In General", Section 16-21 "Loud or unruly gatherings - Public Nuisance", of the Code of Ordinance of the City of Providence is hereby amended as follows:

Sec. 16-21. - Loud or unruly gatherings-Public nuisance.

- (a) *[Defined.]* It shall be a public nuisance to conduct a gathering of five (5) or more persons on any private property in a manner which constitutes a substantial disturbance of the quiet enjoyment of private or public property in a significant segment of a neighborhood, as a result of conduct constituting a violation of law. Illustrative of such unlawful conduct are excessive noise or traffic, obstruction of public streets by crowds or vehicles, illegal parking, public drunkenness, public urination, the service of alcohol to minors, fights, disturbances of the peace, and litter.
- (b) *Notice via posting.* When the police department intervenes at a gathering which constitutes a nuisance under this ordinance, law enforcement shall post a notice on the premises at which such nuisance occurred. The posted notice shall state: a) that police intervention has been required as a result of a public nuisance under this section caused by an event at the premises; b) the date of the police intervention; and c) that if within a six (6) month period from the date of the notice any subsequent event on the same premises requires police intervention, such subsequent event shall result in the joint and several liability of any guests causing a public nuisance, or any persons who own or are residents of the property at which the public nuisance occurred, or any persons who sponsored the event constituting the public nuisance as more fully set forth below. The residents and owner(s) of such property shall be jointly responsible for ensuring that such notice is not removed or defaced, but in the case of an owner, said owner shall not be responsible until fourteen (14) days after notice is mailed pursuant to section (c) below. It shall be an ordinance violation carrying a penalty of a minimum, mandatory one hundred dollar (\$100.00) fine in addition to any other penalties which may be due under this section if such notice is removed or defaced, provided, however, that the residents of the premises or sponsor of the event, if present, shall be consulted as to the location in which such notice is posted in order to achieve both the security of the notice and its prominent display.
- (c) *Notice via mailing.* Notice of the intervention shall also be mailed to any property owner on the city property tax assessment records to advise the property owner that any subsequent such intervention within six (6) months on the same premises shall result in liability of the property owner for all penalties associated with such intervention. In addition, such notices shall state that any removal or defacement of said notice from the property shall be an ordinance violation subject to fines pursuant to section (b) of this ordinance.
- (d) *Enforcement.* Every time that the police department is required to respond to a gathering constituting a public nuisance on the premises within six (6) months of the posting of the notice of police intervention, the following persons shall be jointly and severally liable for a mandatory minimum five hundred dollar (\$500.00) fine.
- (1) The person, persons, or entities that own the property where the gathering constituting the public nuisance took place, provided that notice has been mailed to the owner of the property as set forth herein and the gathering occurs at least fourteen (14) days after the mailing of such notice.
 - (2) The person or persons residing on or otherwise in control of the property where such a gathering took place.
 - (3) The person or persons who organized or sponsored such gathering.
 - (4) All persons attending such gatherings who engage in any activity resulting in the public nuisance.

- (5) Nothing in this section shall be construed to impose liability on the resident or owners of the premises or sponsor of the gathering for the conduct of persons who are present without the express or implied consent of the resident or sponsor, as long as the resident and sponsor have taken all steps reasonably necessary to exclude such uninvited participants from the premises, including landlords who are actively attempting to evict a tenant from the premises. Where an invited guest engages in conduct which the sponsor or resident could not reasonably foresee and the conduct is an isolated instance of a guest at the event violating the law which the sponsor is unable to reasonably control without the intervention of the police, the unlawful conduct of the individual guest shall not be attributable to the sponsor or resident for the purposes of determining whether the event constitutes a public nuisance under this section.
- (6) Proceeds from these fines shall be deposited in a restricted receipts account designated for nuisance abatement in the city.

SECTION 2. This ordinance shall take effect upon passage.

An Ordinance in Amendment of Chapter 18 "Parks and Recreation", Article I "In General", Section 18-22 "Sale or Use of Tobacco Products in Parks" of the Code of Ordinances of the City of Providence.

Section 1. The Code of Ordinances of the City of Providence, Chapter 18 "Parks and Recreation," Article I "In General", Section 18-22 "Sale or use of tobacco products in parks" is hereby amended as follows:

Sec. 18-22. - Sale or use of tobacco and cannabis products in parks.

(a) For the purposes of this section, "tobacco product" means any product containing tobacco or nicotine, including but not limited to cigars, pipe tobacco, snuff, chewing tobacco, dipping tobacco, bidis, snus, dissolvable tobacco products, and electronic cigarettes; provided, however, that such term shall not include any product that has been approved by the U.S. Food and Drug Administration as a tobacco cessation product. For the purposes of this section, "cannabis product" means any product that has been manufactured and contains cannabis or an extract from cannabis, including concentrated forms of cannabis and products composed of cannabis and other ingredients that are intended for use or consumption, including edible products, beverages, topical products, ointments, oils and tinctures.

(b) The sale and use of any and all tobacco and cannabis products is prohibited in all parks, playgrounds, and recreational centers owned by the City of Providence, unless a permit is granted in writing by the superintendent of parks for the sale and/or use of tobacco or cannabis products at a particular site for a specific time frame.

(c) The prohibition on use of tobacco products does not apply to individuals traveling in a vehicle on any public road that runs through a city park.

(d) The use of cannabis products that do not produce smoke or vapors does not apply to persons licensed by the department of health to use cannabis for medical needs.

(e) Any violation of this section is hereby declared to be a public nuisance punishable by a civil fine of fifty dollars (\$50.00). Each sale and/or use shall be deemed a separate violation, and each shall be subject to a separate fine.

Section 2. This Ordinance shall take effect upon passage.

Resolution Recognizing the Month of October as Breast Cancer Awareness Month.

WHEREAS, The American Cancer Society established Breast Cancer Awareness Month in 1985 to promote mammography as the most effective weapon in the fight against breast cancer; and

WHEREAS, A woman is diagnosed with breast cancer every three minutes, and one out of every eight women who live to the age of 85 will develop breast cancer in her lifetime; and

WHEREAS, Even though male breast cancer is very rare, men carry a higher mortality rate than women because of the lack of awareness; and

WHEREAS, Breast cancer is one of the most commonly diagnosed cancers in Rhode Island, and as of July 2020, it accounts for 15% of new cancer cases annually and 7% of cancer deaths; and

WHEREAS, As of January 2022, more than 3.8 million women have a history of breast cancer in the U.S. This includes women currently being treated and women who have finished treatment; and

WHEREAS, The John Hopkins Medical Center encourages adult women of all ages to perform breast self-exams at least once a month to check for lumps and other changes that might indicate the presence of breast cancer; and

WHEREAS, The City of Providence strongly supports the efforts of national, state, and local partners, and of every citizen, who actively engages in public and private efforts to raise breast cancer awareness.

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Providence hereby recognize the month of October as “Breast Cancer Awareness Month” in perpetuity.

Resolution Recognizing the Month of October as Italian American Heritage Month.

WHEREAS, U.S. Presidential Proclamation 6045 of October 1989 established October as Italian-American Heritage and Culture Month to be celebrated every year to honor and recognize the centuries of achievements, successes, and valuable contributions of Italian immigrants and Italian Americans; and

WHEREAS, Italian-Americans have a long and rich history in Providence, with more than 5 million Italian immigrants arriving in the city between 1820 and 2000; and

WHEREAS, In the early 1900s, the Federal Hill neighborhood became one of the most densely populated and largest Italian settlements in the nation; and

WHEREAS, Providence is currently home to thousands of proud Italian-Americans, with 14 percent of the population claiming Italian ancestry; and

WHEREAS, The history of Rhode Island cannot fully be told without identifying the significant contributions of prominent Italian-American figures such as Giovanni da Verrazzano, who gave our state its name, was an Italian explorer and navigator who crossed the Atlantic in 1524 and explored Narragansett Bay; Guido Nincheri the Michelangelo of North America who was an incredible artist, and known to be the most prolific American stain glass artist in modern times; and John O. Pastore, Rhode Island's first Italian American Governor and U.S. Senator; and

WHEREAS, In addition to their significant contributions to the State of Rhode Island, Italian-Americans have also played an essential role in shaping the history of Providence with local figures such as Henry Taylor, the first Italian-American City Councilor, and Dr. Americo A. Savastano, a leader in sports medicine and an early inductee into the Rhode Island Heritage Hall of Fame in 1970, and

WHEREAS, Italian-Americans have been integral in shaping the history of both the State of Rhode Island and the City of Providence and will continue to make significant contributions to the State and City communities for years to come.

Resolution Requesting an easement to install bollards located on Assessor's Plat 7, Lot 360 (99 Taft Avenue).

RESOLVED, DECREED AND ORDERED:

Petitioner Temple Emanu-EL, a domestic nonprofit organization located at 99 Taft Avenue in Providence, has requested an easement over a portion of the sidewalk abutting their property. The City hereby grants Temple Emanu-El an easement over the shaded portion of the public right-of-way abutting Taft Avenue shown on the accompanying plan entitled "Providence, R.I., P.W. Dept-Engineering Office, Street Line Section Plan No. 064873, dated May 12, 2022," bounded by letters the A-B-C-D-A on said plan, for the purpose of installing a line of concrete bollards. Said easement shall have the following conditions:

1. This easement is appurtenant to the property at 99 Taft Avenue, more specifically described as Assessor's Plat 7 Lot 360, and shall run with the land.
 2. The design, maintenance, and upkeep of the bollards shall be the responsibility of Petitioner, its successors, and assigns.
 3. The placement of the bollards shall be the responsibility of Petitioner, its successors, and assigns, but any bollards must be placed in a manner compliant with the Americans with Disabilities Act of 1990, as amended, and its corresponding accessibility guidelines, as amended.
 4. Petitioner shall apply for all applicable permits, including for excavation, for the installation of the bollards.
