No. 262 AN ORDINANCE AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1565, BY APPROPRIATING THE SUM OF THIRTY THOUSAND FIVE HUNDRED SEVENTY SIX (\$30,576) DOLLARS TO POLICE DEPARTMENT, ITEM 0 and SEVEN THOUSAND THREE HUNDRED SIXTY FIVE (\$7,365) DOLLARS TO POLICE DEPARTMENT, ITEM 2.

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1565 of the Ordinances of the City of Providence, as approved September 24, 1963 entitled: "An Ordinance Making Appropriation of \$44,468,244.36 for the Support of the City Government for the Fiscal Year Ending September 30, 1964", as amended, is hereby further amended by appropriating the sum of Thirty Thousand Five Hundred Seventy Six (\$30,576) Dollars to Police Department, Item 0 and Seven Thousand Three Hundred Sixty Five (\$7,365) Dollars to Police Department, Item 2.

SECTION 2. The said sum of Thirty Seven Thousand Nine Hundred Forty One (\$37,941) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Thirty Seven Thousand Nine Hundred Forty One (\$37,941) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.



SECTION 1. Section 1 of Chapter 1567 of the Ordinances of the City of Providence approved September 24, 1963, as amended, is hereby further amended in the following manner:



No. 264 AN ORDINANCE AMENDING SECTION 165.2 OF CHAPTER 2 OF THE 1946 REVISED ORDINANCES, ENTITLED, "ADMINISTRATION", AS AMENDED, BY ADDING A CERTAIN HOLIDAY, RELATIVE TO MEMBERS OF THE POLICE DEPARTMENT.

Approved April 17, 1964

Be it ordained by the City of Providence:

SECTION 1. Section 165.2 of Article XV of Chapter 2 of the 1946 Revised Ordinances, entitled, "Administration" as amended, is hereby further amended to read as follows:

Sec. 165.2 HOLIDAY PAY FOR POLICEMEN and FIREMEN

Policemen and firemen, whether on duty or not, shall be entitled to and shall receive one extra day's pay for the following holidays; said pay to be computed on a basis of one-fifth of a full week's pay, viz.:

- New Year's Day
Independence Day
Labor Day
Columbus Day
Armistice Day
Thanksgiving Day
Christmas Day

In addition thereto policemen shall be entitled to Memorial Day on the same terms and conditions as hereinbefore set forth.

SECTION 2. This Ordinance shall take effect upon its passage.



No. 265 AN ORDINANCE AMENDING SECTION 43.2 of CHAPTER 2 of the 1946 REVISED ORDINANCES, ENTITLED, "ADMINISTRATION", AS AMENDED, RELATIVE TO UNIFORM ALLOTMENT IN THE POLICE DEPARTMENT.

Approved April 17, 1964

*Be it ordained by the City of Providence:*

SECTION 1. The last paragraph of Section 43.2 of Article III of Chapter 2 of the 1946 Revised Ordinances, as amended, is hereby further amended to read as follows: Subsequent to his first full year of service each uniformed police officer, detective and police driver shall be entitled to receive one hundred five dollars each year. Said sums shall be paid at such times and upon such terms and conditions as may be prescribed by rule or regulation adopted by Commissioner of Public Safety and approved by the City Controller.

SECTION 2. This Ordinance shall take effect as of October 1, 1963.




