ORDINANCES SECOND READING

The following Ordinances were in City Council July 18, 1996, Read and Passed the First Time, as Amended, and are Severally Returned for Passage the Second Time, as Amended:

An Ordinance in amendment of Chapter 1987-10 of the Ordinances of the City of Providence, as approved May 11, 1987, as amended in Chapter 1988-45, November 23, 1988, as amended in Chapter 1989-18, April 17, 1989 and as amended in Chapter 1995-4, April 30, 1995; entitled: "An Ordinance creating and establishing an Economic Development Zone within the City of Providence pursuant to 3-7-16.4 of the General Laws of the State of Rhode Island", as amended.

Be it ordained by the City of Providence:

Whereas, The City Council, pursuant to Rhode Island General Laws Section 3-7-16.4, created and established an economic development zone necessary for the purpose of encouraging commercial and industrial investment; and

Whereas, The boundaries of said economic development zone were set forth in Exhibit A of

Chapter 1988-45, attached thereto and incorporated by reference; and

Whereas, The City Council desires to modify the boundaries of said economic development zone;

Now, therefore, be it ordained by the City of Providence:

That portion of the economic development zone located "Number 1" attached and incorporated by reference in Chapter 1988-45 as amended, is hereby amended pursuant to R.I.G.L. 3-7-16.4 as shown in Exhibit "A" which was attached to the amendment dated April 30, 1995 (Chapter 1995-4) for the purpose of licensing Class ED Retail Alcoholic Beverage Licenses, is further amended by extending the southerly boundary of the economic development zone within Census Tract 9, in a southerly direction, to a line running parallel to Atwells Avenue and extending one hundred (100) feet from the centerline of said Atwells Avenue.

An Ordinance amending the City of Providence Zoning Ordinance Chapter 1994-24, No. 365, approved June 27, 1994, as amended.

Be it ordained by the City of Providence:

Section 1. The Providence Zoning Ordinance Chapter 1994-24 No. 365, approved June 27, 1994, as amended shall be further amended as follows:

a) Section 303, Table of Use Regulations, Use Code 21, add footnote #1 to all items marked with an "S" Special Use Permit.

b) Renumber existing footnotes #1 through 6 to footnotes #2 through 7, respectively.

c) New footnote #1 shall read as follows:

"Any institution, as defined in Use Code 21,

at its own option, may apply for a Special Use Permit to the Zoning Board of Review, in accordance with Section 902.4 of this Ordinance or it may apply to the City Plan Commission under Section 421 of this Ordinance and be considered a Major Land Development Project. Procedures for the approval of Major Land Development Projects are contained in the Development Review Regulations adopted by the City Plan Commission pursuant to RIGL Section 45-23-25 through 74."

d) Delete Section 421 in its entirety and replace with the following new Section 421, to read as follows:

Section 421 — Major Land Development Project — Approval by City Plan Commission: A Major Land Development Project, is a parcel or parcels of land, containing at least forty thousand (40,000) sq. ft. of land area, which is developed according to a plan in accordance with this Section as a single entity. The Major Land Development Project may include one or more residential and/or commercial structures with appurtenant recreation buildings, common areas, open space and roadways or an educational institution (primary through secondary schools) as defined by Use Code 21. The purpose of a Major Land Development Project is to allow for the creation of multifamily, mixed use developments or primary through secondary schools through careful site planning.

421.1 Establishment: A Major Land Development Project may be established upon approval by the Commission in any zone in which the proposed principal use and accessory uses of each building are permitted in accordance with Article III. A Major Land Development Project may be initiated by submitting a major land development plan to the Commission in accordance with the Development Review Regulations adopted by the City Plan Commission pursuant to RIGL Section 45-23-25 through 74.

421.2 Primary through Secondary Schools — Master Plan Requirement: Any educational

institution (primary through secondary schools) as defined by Use Code 21 that chooses to apply to the City Plan Commission under Section 421 of this Ordinance as a Major Land Development Project, shall prepare and submit a Master Plan in accordance with Section 503.2 C) 1. through 11 of this Ordinance.

Section 2. This Ordinance shall take effect upon passage.

Be it ordained by the City of Providence:

Section 1. The Providence Zoning Ordinance Chapter 1994-24 No. 365, approved June 27, 1994, as amended shall be further amended as follows:

Section 103 A) — Official Zoning Map — Providence Zoning District Map 34, dated October 24, 1991 and amended June 27, 1994, shall be further amended as follows:

Change from C-2 General Commercial to C-4 Heavy Commercial: Lots 320 and 313 on Zoning District Map 34.

Section 2. This Ordinance shall take effect upon passage.

Resolution Ordering the abandonment of a portion of Memorial Square, also known as Fulton Street and formerly known as Post Office Square.

Resolved, decreed and ordered:

That the following named street shown as cross-hatched area on the accompanying plan entitled: "Providence, RI Department of Public Works — Engineering Office, Street Line Section Plan No. 064572 dated November 30, 1995."

viz:

A portion of the street now known as Memorial Square and formerly known as Post Office Square, shown as cross-hatched area on accompanying plan and designated by the letters (B-E-F-C-B) having ceased to be useful to the public and is proposed to be abandoned as a Public Highway. Said Abandonment shall be in favor of the General Services Administration acting as agent for the United States of America said abandonment is specifically conditioned precedent upon the following: (1) Petitioners shall convey an easement acceptable to the City of Providence, Department of Public Works, which will permit retention of its sewer facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation; (2) Petitioners shall convey an easement accep-

table to the Providence Water Supply Board which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation; (3) Petitioners shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation; (4) Petitioners shall convey an easement acceptable to the New England Telephone & Telegraph Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the petitioner shall assume all costs of relocation; (5) Petitioners shall, at Petitioners' sole cost and expense, obtain a survey of the subject property by a licensed surveyor and shall deliver that survey to the Director of the Department of Public Works so that the specific bounds of the abandonment shall be mutually agreed upon between the Petitioners and said Director; (6) Petitioners have indicated that the

abandonment is sought so as to provide additional security for persons utilizing the Federal Court buildings. Any construction shall be aesthetically and architecturally compatible with the surrounding areas and

(a) The design of the proposed security fence will be subject to review and approval of the Downcity Review Commission for the compliance with the Downcity District regulations. Such approval must be obtained before the fence is installed;

(b) The design of the proposed fence will also be subject to the approval of the Rhode Island Historical Preservation and Heritage Commission, in accordance with Section 106 regulations. Such approval must be obtained before the fence is installed;

(c) The United States government shall maintain the surrounding curb and sidewalks around the entire property as an open walkway, accessible for public access at all times.

(7) Said abandonment shall remain in effect for so long as said premises are used as part of a security system for the United States Courthouse; but in the event it is not used for said purpose, the land shall automatically revert to the

City without the need for any further action by the City.

And it is further

Ordered, That the Traffic Engineer be and he is hereby directed to cause a sign to be placed on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway", and it is further

Ordered, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.
