MEMORANDUM

DATE: March 27, 1973

TO: Councilman Pisaturo

SUBJECT: WEST BROADWAY AND SOUTH PROVIDENCE DEVELOPMENT PROJECTS

CONSIDERED BY: City Clerk Vespia

DISPOSITION: Pursuant to your request, Director Pallozzi informs
as follows:

1. With respect to the question how much the City of Providence would lose in Federal funds as a result of President Nixon's freezing of certain development funds in the West Broadway Project, between five and seven million dollars in annual appropriation until project is completed, probably in a total of fifteen million dollars.
2. Director Pallozzi states with respect to the South Providence Project, he cannot determine the projected course and stated categorically that whatever appropriation would be available would simply not be sufficient to complete this cost because of the enormous development required in the area.
