
Dear Mr. Vespia:

This is in connection with the Resolution of the City Council requesting this Authority to install new door locks at Admiral Terrace and Chad Brown and to provide a Security Force for said projects, as set forth in your Memorandum dated January 23, 1968.

Please be advised that a program has already been started to replace the locks at said projects.

With respect to a Security Force for said projects, the Authority is prevented from setting up such a force by Federal regulation. However, we have endeavored to provide some security to the extent of our limited resources. We have been advised by the Federal agency supervising our operations that recent legislation has been enacted whereby Federal funds may be obtained for such purpose. Preliminary steps are being taken in the hope that this much needed security be put into effect.

Dear Mayor,

During the fiscal year, October 1, 1966 thru September 30, 1967, the office of the Recorder of Deeds received for record 11,310 documents.

Miscellaneous, Writs, Attachments, etc.	3459

A fee was charged for recording 10,156 documents which resulted in gross receipts of \$32,935.05.

It should be noted that we received for record 1078 documents from the office of Minimum Housing of the Department of Housing and Urban Development for which a fee was not charged. This is a sixteen per cent increase over the previous year. A fee should be charged for the recording of these documents. There is no other division of the City of State Government that does not pay a fee for their recordings.

With the increased costs of operations, our operating net cost was \$35,367.16.


I recommend an increase in recording fees, to enable us to operate more economically.



TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE

In complying with the ordinances of the City of Providence, the Board of Park Commissioners present the following report of the North Burial Ground for the year 1967.

During the year 1967, the sum of \$ 4,124.00 was received for Perpetual Care of Lots and Single Graves.

During the year 1967, there were 404 interment, making a total of 63,286 since 1848, that being the first year that records of interments were kept.

130 foundations for Headstones or Monuments were built.

There were 42 Lots placed under Perpetual Care and 72 Single Graves placed under Perpetual Care.

The present number of lots under Annual Care, 12.

Number of Lots now held in Perpetual Trust, 317.

The average number of employees during the year was 16.

Inventory of Removable Property at the North Burial Ground for the fiscal year ending September 30, 1967, \$ 19,558.92.




