ORDINANCES SECOND READING

An Ordinance Empowering the City Council of the City of Providence to Exempt from Local Taxation, the Real and Personal Property of the Providence Turners within Said City.

Be it ordained by the City of Providence:

Section 1. The City Council of the City of Providence is hereby empowered to exempt from taxation the real and personal estate of "The Providence Turners," located at 118 Glenbridge Avenue, within and situated in the City of Providence.

Sec. 2. This Ordinance shall become effective upon its passage by the City Council and approval by the Mayor.

An Ordinance Amending the Appropriation Ordinance Chapter 1977-35, Approved July 18, 1977, by Appropriating a Sum Not to Exceed Fifty Thousand Dollars (\$50,000.00), for the City of Providence's Food Stamp Program.

Be it ordained by the City of Providence:

Section 1. Chapter 1977-35 of the Ordinances of the City of Providence, as approved July 18, 1977 and entitled: "An Ordinance Making Appropriation of \$108,255,372.79 for the Support of the City Government for the Fiscal Year Ending June 30, 1978, as amended" is hereby further amended by appropriating the sum of Fifty Thousand Dollars (\$50,000.00) for the City of Providence Food Stamp Program. Said sum to be transferred to the Revolving Fund and any unspent monies shall revert back to the General Fund.

Sec. 2. The said sum of Fifty Thousand Dollars (\$50,000.00) as thus added and appropriated shall be obtained by authorizing and directing

the City Controller and the City Treasurer to transfer a like sum from funds not otherwise appropriated.

Sec. 3. This Ordinance shall take effect upon its passage.

No person shall post or otherwise affix, nor cause to be posted or affixed, any bill, poster, or notice upon any tree, fence, board, post, pole or Rhode Island Public Transit Authority Bus Shelters or other structures within or upon the occupation line of any street or highway and no person shall paint, print, mark, or cause to be painted, printed or marked, any sign, notice or advertisement upon any tree, fence, board, post, pole or Rhode Island Public Transit Authority Bus Shelter or other structure within or upon the occupation line of any street or highway, except with the approval, in writing, of the Committee on Public Works of the City Council and subject to conditions as said Committee may impose respecting the same.

Sec. 2. This Ordinance shall take effect upon its passage.

Resolution Authorizing the City Treasurer, Acting Under the Direction of the Committee on Finance to Issue Interest Bearing Notes Not to Exceed Eight Million, Five Hundred Thousand Dollars (\$8,500,000.00), in Accordance with the Provisions of Section 3 of Chapter 160 of the Public Laws of 1977, for Sewage Treatment Plant, Repair and Rehabilitation.

Resolved, That

Section 1. The City Treasurer, acting under the direction of the Committee on Finance, from time to time may issue and refund not exceeding Eight Million Five Hundred Thousand Dollars (\$8,500,000.00) interest bearing or discounted notes under Section 3 of Chapter 160 of the Public Laws of 1977 in anticipation of the issuance of bonds authorized by Chapter 1977- of the Ordinances of the City of Providence.

Sec. 2. The Mayor and the City Treasurer from time to time may issue and refund interest bearing or discounted notes under Section 3 of Chapter 160 of the Public Laws of 1977 in anticipation of federal or state aid for the purposes

specified in said Chapter 160 of the Public Laws of 1977. The amount of such original notes issued in anticipation of federal or state aid may not exceed the amount of available federal or state aid as estimated by the City Treasurer.

Sec. 3. The manner of sale and the forms denominations, maturities, interest rates and other details of the notes shall be fixed by the Mayor and the City Treasurer.

Sec. 4. The Mayor and the City Treasurer from time to time may subject to and pursuant to Section 9 of Chapter 160 of the Public Laws of 1977, apply for, contract for and expend any federal or state advances or other grants or assistance which may be available for the purposes specified in said Chapter 160 of the Public Laws of 1977.

Sec. 5. Pending the issue of bonds pursuant to Chapter 1977-___ of the Ordinances of the City of Providence or pending or in lieu of the issue of notes under Section 1 or Section 2 hereof, the City Treasurer with the written approval of or written ratification by the Mayor, may expend funds from the general treasury of the City for the purpose specified in Chapter 160 of the Public Laws of 1977. Any advances made under this section shall be repaid without interest from the proceeds of bonds issued under Chapter 1977-___ of the Ordinances of the City of Providence or of notes issued hereunder or from the proceeds of applicable federal or state assistance or from other available funds.

Sec. 6. This Resolution shall take effect upon its passage, and all other resolutions or parts thereof inconsistent herewith are hereby repealed.

Resolution Requesting the Acting City Solicitor to Appear before the Next Session of the General Assembly and Urge Passage of An Act in Amendment to Section 6.32 of the Charter of the City of Providence Pertaining to "Annual Audit of Financial Accounts."

Resolved, That the Acting City Solicitor be and he hereby is requested to appear before the next session of the General Assembly to amend that Provision of the City Charter being Section 6.32, entitled "Annual Audit of Financial Accounts" to be consistent with the fiscal year of the City of Providence which reads as follows:

"Sec. 6.32. Annual Audit of Financial Accounts.

Not later than June 15 of each year the City Council shall provide for an audit of the financial accounts of the city. For the purpose of this audit the council shall employ either the services of one or more certified public accountants, none of whom shall be officers or employees of the city government and who shall hold a certificate from the State of Rhode Island or from some other state maintaining an equal standard of professional requirements, or the bureau of audits and accounts of the State of Rhode Island, to perform such annual audit. If the council fails to provide for such audit by June 15th in any year, such failure shall be deemed the equivalent of a direct request of the state bureau of audits and accounts for such an audit.

The audit shall be made in accordance with generally accepted auditing standards and shall include all procedures necessary to enable the accountant or accountants to express an informed opinion of the financial accounts. A copy of the accountants' report shall be kept on file by the city clerk and shall be a public record.

The period covered by the audit shall be for one complete fiscal year beginning on July first prior to the action of the city council as herein required, and shall run to June 30 subsequent to the date of the council action; provided, however, in the event the books, records, and accounts of the city for the preceding fiscal year were, for any reason not audited, the council shall provide that the audit authorized as herein provided shall cover the entire period from the last preceding audit.

All officers of the city shall be required to extend such assistance and make available, such records as the accountant or accountants may request. Failure on the part of any officials to perform the duties as herein required shall be deemed nonfeasance of office and (said officials) shall forfeit their right to the office."
