No. 347 AN ORDINANCE

AMENDING THE APPROPRIATION ORDINANCE
CHAPTER 1972-32, APPROVED JUNE 23, 1972, BY APPROPRIATING
THE SUM OF TWO HUNDRED EIGHTY FOUR THOUSAND SEVEN HUNDRED
FIFTY ONE DOLLARS (\$284,751.00) TO VARIOUS DEPARTMENTS.

Be it ordained by the City of Providence:

SECTION 1. Chapter 1972-32 of the Ordinances of the City of Providence, as approved June 23, 1972 entitled: "An Ordinance Making Appropriation of \$76,070,746.51 for the Support of the City Government for the Fiscal Period Beginning July 1, 1972 and Ending June 30, 1973", as amended, is hereby further amended by appropriating the sum of Two Hundred Eighty Four Thousand Seven Hundred Fifty One Dollars (\$284,751.00) to the following items and the following departments.

1) SCHOOL DEPARTMENT	ITEM 0	\$236,751.00
2) DEPT. COMMUNICATIONS	ITEM 1	30,000.00
3) FIRE DEPT.	ITEM 1	18,000.00

SECTION 2. The said sum of Two Hundred Eighty Four Thousand Seven Hundred Fifty One Dollars (\$284,751.00) as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer Two Hundred Eighty Four Thousand Seven Hundred Fifty One Dollars (\$284,751.00) from the Reserve for Extraordinary Expenditures Account to the Receipts Account.

SECTION 3. The Estimated Receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Two Hundred Eighty Four Thousand Seven Hundred Fifty One Dollars (\$284,751.00).

SECTION 4. This Ordinance shall take effect upon its passage.
