Smith did devise and bequeath to the City of Providence all of his estate, the net income to be used for the beautification of its park system, and for the construction of greenhouses in Roger Williams Parks, thus affording the public the opportunity of enjoying these facilities, and

WHEREAS, in the interest of progress, the said greenhouses and the area occupied by such, have been condemned by the State of Rhode Island for highway purposes, thus requiring the selection of a new site and the construction of a series of greenhouses.

NOW THEREFORE BE IT RESOLVED, That in order to perpetuate the memory of this man, whose interest in preserving the beauty of the City is evident everywhere, the City Council does hereby request the Board of Park Commissioners to designate the proposed series of greenhouses, to be erected upon an area located at Gladraustus Avenue and Floral Avenue in Roger Williams Park, as "Charles H. Smith Memorial Greenhouses."


