Re: Legal Opinion: Bradley's Cafe


Gentlemen:

Regarding your correspondence of July 15, 1977,
the following is the opinion of the undersigned.

Although case law in Rhode Island seems to suggest that it would be a denial of constitutional right to order Bradley's Cafe to be closed at 12:00 o'clock midnight, it also appears that the Bureau of Licenses may suggest to the City Council that which appears in the proposed resolution and that the City Council may legislatively seek the ends that the bureau has stated. I believe Rhode Island case law states specifically that the legislative body of any governmental organization may selectively, by resolution, do what it would not be able to achieve through the courts.

Therefore, it is the opinion of the undersigned that the proposed resolution by your bureau is legal and once submitted to the City Council and passed will effectively achieve that which is contained within the resolution.
