The Bureau of licenses submits herewith a report of its activities for the year ending-December 31, 1964.

The Bureau has authorized the issuance of 13,457 licenses of various types and has held approximately 127 informal hearings. The Bureau conducted 70 hearings at which licensees violating the provisions of the law or the Rules of the Bureau of Licenses have been summoned and disposition made of the cases as follows:
