On December 6, 1965, at the direction of the Mayor, this Division began an intensified "crash program" inspection of United States Census Tracts 4, 6 and 7, which comprise the Upper South Providence area. One hundred percent of our resources were allocated to this effort and violations in other sections of the City were answered on a complaint basis only.

Since this City has the nation's highest proportionate annual budgetary allocation for code enforcement, the Upper South Providence area, for the past year, has received perhaps the most intensified code enforcement of any community in the world. This statement is augmented by the fact that, at times, our field staff of 11 was increased by 25 percent with assistance from Relocation inspectors, who worked with us for months.

In addition to our regular housing code enforcement surveys, detailed APHA surveys were made on each and every structure to provide vital information for future application for federal grants.

The Division is still working its crash program in this area. During this period, 40 fire traps were eliminated and over 300 houses were painted. Almost 500 homes have corrected "electrical fixtures" deficiencies, which constitute a shortage of outlets or plugs. National Safety Council Authorities stress that the best deterrent for "octopus wiring", which is extremely dangerous, is adequate electrical convenience outlets. Dangerous wiring has been corrected in 172 dwelling units.

On September 6, 1966, we began our program of prosecutions. At this date, we have arraigned the owners of 180 structures, many of which have more than one owner.

Despite the vigorous effort made by this Division, less than a third of the violations have been corrected and a good percentage have been corrected purely through court action, making it obvious that unrelenting prosecution will be necessary in order to make progress in this area.

On April 22, 1966 the City of Providence was awarded \$799,989.00 for the inauguration of federally-assisted housing code enforcement and neighborhood rehabilitation in two areas. It is expected that this program will get under way early this coming year.

The continued prosecution program resulted in a total of 1,489 arraignments and appearances in Police Court for the owners of sub-standard houses. There were 11 trials, which resulted in a total of \$585.00 in fines.

During the year the subcommittee on housing code enforcement of the Mayor's Citizens Advisory Committee on Urban Renewal met regularly. A very valuable and well-written Committee report was drafted by member, Dr. James P. Adams. After signed approval by all members, it was presented to the Mayor.

Once again, the Division won international recognition when Edmonton, Alberta, Canada; a city of over 400,000 people, sent their Director of Minimum Housing for an intensive two-week training program here.
