No. 196 AN ORDINANCE AMENDING SECTION 163.2 OF
CHAPTER 2 OF THE REVISED ORDINANCES, 1946, RELATIVE TO
VACATIONS.

Approved March 17, 1961

Be it ordained by the City of Providence:

SECTION 1. Section 163.2 of Article 15 of Chapter 2
of the Revised Ordinances, 1946 entitled "Administration, Officers
and Employees Generally", is hereby amended to read as follows:

Section 163.2 Same--Rules and regulations to be established
by Finance Director, six weeks maximum accumulation.

The Finance Director shall establish rules and regula-
tions governing annual vacations provided that vacation periods
may not be accumulated so as to exceed six calendar weeks.
