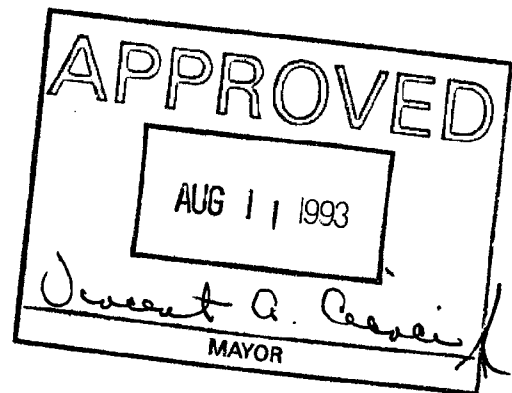

SUBJECT: CITY COUNCIL RESOLUTION NOS. 535, 536, 537 AND 541

Pursuant to those City Council Resolutions encaptioned above, I have investigated each matter and found the following:

NO. 535 - REPAIR OF FLORENCE STREET RETAINING WALL

Joseph Salem, Director of Grounds Maintenance, reports that this work has been planned and these repairs are scheduled to take place within the next few weeks.

NO. 536 - CUTTING OF GRASS AT THE SACKETT STREET AND ROGER WILLIAMS SCHOOLS

Joseph Salem reports that the Parks Department had been awaiting a funding allocation from the School Department which would enable the Parks Department to purchase equipment necessary to maintain these areas. That allocation having been received, the School properties in question have now been added to the normal grass-cutting rotation work done by the Division of Grounds Maintenance.

NO. 537 - ALTERNATE LEARNING PROJECT GRASS CUTTING

Joseph Salem reports that this site is not under the jurisdiction of nor maintained by the Parks Department.

NO. 541 - SIGNS FOR CABRAL PARK

Alan Sepe has reported that these signs have been ordered and the same will be installed once received.
