TO THE HONORABLE CITY COUNCIL OF THE CITY OF PROVIDENCE:

The undersigned respectfully petition your honorable body

to change Lot 511 on Plat 63 from an R-4 Multiple Dwelling Zone to
a C-4 Heavy Commercial Zone; more particularly described as
follows:

That parcel of land with all buildings and improvements thereon,
situated on the southwesterly side of Curtis Street in the City of
Providence and State of Rhode Island, bounded and described as
follows:

Beginning at a point in the southwesterly line of Curtis Street
at the northerly corner of said parcel and at the easterly corner of
land now or lately of Ludger Dionne and wife, said point being one
hundred nineteen and 88/100 (119.88) feet, more or less, southeasterly
from the point of intersection of said line of Curtis Street with the
southeasterly line of Sheridan Street; thence southeasterly sixty (60)
feet to Panay Street (formerly Oyama Street) as shown on the plat

**Re : Non-Discrimination in Public Facilities in

In addition to the resolution previously adopted by City Council recognizing the Presidential executive order prohibiting discrimination because of race, creed, or national origin within the proposed Weybosset Hill Project Area, the Federal Government requests a special resolution indicating that all public facilities within the proposed Weybosset Hill Project to be furnished as a non-cash local grant-in-aid must be open to all without regard to race, color, creed, or national origin.

The attached resolution meets the requirements of the Federal Government and it is respectfully requested that the City Council adopt this resolution at the next meeting.

A N A C T

IN AMENDMENT OF CHAPTER 1898 OF THE 1947 PUBLIC LAWS
 AUTHORIZING A ONE MILLION FIVE HUNDRED THOUSAND (\$1,500,000)
 DOLLAR BOND ISSUE BY THE CITY OF PROVIDENCE FOR SCHOOL
 ATHLETIC FIELDS, AS AMENDED.

It is enacted by the General Assembly as follows:

Section 1. Section 1 of chapter 1898 of the 1947 public laws entitled "An act authorizing the city of Providence to issue bonds in the amount of \$1,500,000 for the acquisition and/or improvement of school athletic fields, including the purchase or condemnation of land for such purposes" as amended by Chapter 166 of the 1962 Public Laws, is hereby further amended to read as follows:

"Section 1. The city of Providence is hereby authorized and empowered, in addition to and not in substitution for authority previously granted, to issue, in addition to the bonds heretofore issued and now outstanding, under its corporate name and seal, serial bonds in any form which the city council of said city may approve in an amount not exceeding \$1,500,000. Said bonds shall be of any denomination not exceeding \$20,000 each; the principal thereof and the interest thereon shall be payable in any coin or currency of the United States of America, which at the time of payment is legal tender for public and private debts, and the debts incurred by said bonds shall be obligatory on said city in the same manner and to the same extent as other debts lawfully contracted by said city. The dates of maturity of said bonds

shall, in no case, be more than twenty-five (25) years after date of issue and not less than three and one-half percent nor more than six and one-half per cent of the principal amount of said bonds issued shall become due and payable in any one year; provided, however, that no bonds issued under the provisions of this act shall mature within five years after the date of issuance nor later than the year 1990.

Sec. 2. This act shall take effect upon its passage and all acts or parts of acts inconsistent herewith are hereby repealed.
