


AUTHORIZING THE CITY OF PROVIDENCE TO OWN CERTAIN PROPERTY ABSENT  
DEED RESTRICTIONS

Introduced By: Senators Igliazzi, Graziano, F Caprio, Kells, and Walton

Referred To: Senate Corporations

It is enacted by the General Assembly as follows:

1           SECTION 1. The city of Providence, as owner of certain property located on Wheaton  
2 Street in said City which was conveyed to it by a certain deed from Rhode Island Hospital Trust  
3 Company dated March 13, 1929 and recorded March 23, 1939 at 2:50 pm in the Land Evidence  
4 Records of the City of Providence in Book 820 at pages 233 through 235; and

5           Whereas the terms of said deed the property is to be used "for park and playground  
6 purposes"; and

7           Whereas it is no longer in the best interest of the city of Providence to continue to own  
8 said property subject to said restriction; is hereby authorized, notwithstanding any general law to  
9 the contrary, to own this property from henceforth free of said restriction. Any conveyance of  
10 said property by the city of Providence will not be subject to the limitations set forth in R.I.G.L.  
11 section 24-6-2, as amended.

12           SECTION 2. This act shall take effect upon passage.

It is enacted by the General Assembly as follows:

1           SECTION 1. Section 1 of chapter 1034 of the January session, 1941 Public Laws entitled  
2    "An Act Authorizing the Rhode Island Roger Williams Memorial Association to convey to the  
3    city of Providence Certain Lands to be held by said city as a Parkway Approach to the Roger  
4    Williams Monument on Prospect Terrace in said city and as a Memorial of Roger Williams" is  
5    hereby amended to read as follows:

6           SECTION 1. The Rhode Island Roger Williams Memorial Association, a corporation  
7    created by act of the general assembly passed at its January session A.D. 1934, is hereby  
8    authorized to convey to the city of Providence the two lots of land situated respectively on  
9    Benefit and Wheation streets therein, which were conveyed to said association by The Yearly  
10   Meeting Of Friends For New England and the Roger Williams Savings Fund and Loan  
11   Association by their respective deeds dated October 30, 1940 and October 29, 1940, and recorded  
12   in the office of the recorder of deeds in said city in deed book No. 810 at pages 481 and 482, and  
13   also any land or lands adjoining wholly or in part said lots or either of them which hereafter may  
14   be acquired by said association and upon the acceptance by said city of the dead or deeds  
15   conveying said lands or any thereof to said city, the same to be held and used by said city for  
16   what ever purposes the City Council shall decide are in the best interests of the City. As of June  
17   1, 2002, the property described in this Public Law shall not be subject to the limitation of R.I.G.L.  
18   45-2-6 upon the power of the City Council of the City of Providence. Any deed of conveyance of  
19   the property that is the subject of this Public Law, as amended, shall include a reference to this

1 Public Law, as amended.

2 SECTION 2. This act shall take effect upon passage.
