Dear Mr. Solomon:

It is my understanding that Lisa Bortolotti is under consideration for appointment as an Associate Judge of the Providence Municipal Court. I have known Ms. Bortolotti for more than twenty years and I feel very comfortable recommending her for this important position.

Lisa Bortolotti began her legal career as a law clerk in the Workers' Compensation Court. She was actually here at the Court while the 1992 workers' compensation reform legislation was drafted. Thereafter, she was employed with the Rhode Island Department of Labor and Training as legal counsel and was a valuable asset in crafting administrative procedures to respond to the provisions of the new law. In particular, Lisa was actively involved with drafting the rules to address appeals from the Department of Labor and Training to the Workers' Compensation Court and, similarly, from the Medical Advisory Board to the Court. In each task, she demonstrated a remarkable understanding of the Administrative Procedures Act and the requirements the department had to meet to ensure a full due process hearing to all appellants. While there have been some minor revisions to the rules Lisa created, the Court continues to rely upon them as they were originally crafted by her.



It is also important to note that the Workers' Compensation Court has an Appellate Division and Ms. Bortolotti routinely appeared before the Appellate Division as well as the Rhode Island Supreme Court. She is an effective legal writer and always presents logical, well-crafted and eloquent arguments in support of her position. She consistently demonstrated creativity and legal acumen and served as a diligent representative for the Department at every stage of litigation. In addition, she represented the Department at the General Assembly to explain their legislative package and to answer questions from interested senators and representatives.
