The Superior Court affirmed that we do have the right to say "No". No is only a two letter word. ONE OF THE SMALLEST WORDS that has ever been uttered on this Council floor. BUT, IT IS PROBABLY THE MOST IMPORTANT and I personally want to thank each of you for the courageous stand that this Council has taken. It

is my belief that this present Council is the best that I have ever seen in my 30 years of being involved in politics. I hope that the next Council and the City Council's that follow can have the courage that this Council has shown. It was not easy to stand up to the Unions and the Administration. But, we did and we won! Thank you all.
