**AN ORDINANCE** IN AMENDMENT OF CHAPTER 1994-4, AS APPROVED FEBRUARY 15, 1994, ENTITLED: "AN ORDINANCE AMENDING CHAPTER 9 OF THE CODE OF ORDINANCES OF THE CITY OF PROVIDENCE, ENTITLED: 'FIRE PREVENTION AND PROTECTION', AS AMENDED".

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 9 of the Code of Ordinances of the City of Providence entitled: "Fire Prevention and Protection," is hereby amended to read as follows:

### ARTICLE III. CHARGES FOR EMERGENCY MEDICAL SERVICES. Section 9-37. Fees.

Each person receiving emergency medical services in the City of Providence shall be billed for the following fees, if applicable:

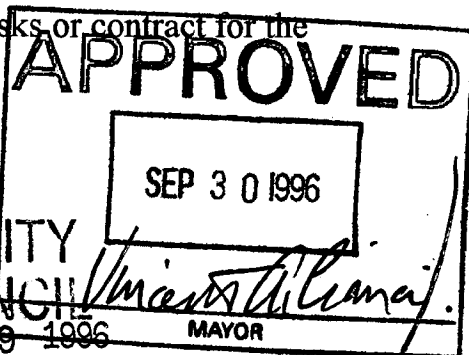
