

# RESOLUTION OF THE CITY COUNCIL

No. 385

*Approved* July 17, 2001

## RESOLVED, DECREED, AND ORDERED:

That the following-named street shown on a cross-hatched area on the accompanying map entitled "Prov., RI, DFW-Engineering Office, Street line Section Plan Number 064667 dated July 6, 2001.

VIZ: Kennedy Plaza, so-called, (portion of) as described in Attachment "A" and shown as a cross-hatched area on the accompanying plan and designated by the letters A-B-C-D-E-F-A, having ceased to be useful to the public and is proposed to be abandoned as a public highway. Said abandonment is specifically conditioned precedent upon the following:

1. The petitioner shall convey an easement acceptable to the Narragansett Electric Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation.

2. The Petitioner shall convey an easement acceptable to Providence Gas Company which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the Petitioner that any such facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation;

3. The Petitioner shall convey an easement acceptable to Verizon which will permit retention of its facilities in their existing location, together with the right to inspect, maintain, operate and replace the same and with twenty-four hour access to said facilities, or in the alternative should it be determined by the Petitioner that any such

facilities need be relocated in order to comply with an intended use, the Petitioner shall assume all costs of relocation;

4. Petitioner shall comply with all conditions contained herein not later than sixty (60) days from its approval. Upon failure to so comply for any reason, the within resolution shall automatically become a nullity.

ORDERED, That the Traffic Engineer be and he is hereby directed to cause a sign to be place on the above-named highway abandoned as aforesaid, having thereon the words, "Not a Public Highway," and it is further

ORDERED, That after the entry of this order or decree the City Clerk shall cause a notice thereof to be published in a newspaper, published in the County of Providence at least once a week for three successive weeks and a further and personal notice shall be served by the City Sergeant upon every owner of land abutting the above-named highway which has been abandoned, who is known to reside within the State.

Pursuant to yours and Councilman Clarkin's request I have completed an Estimate of Value for this abandonment. Kennedy Plaza is owned by the City and is zoned Open Space. The request is to determine Fair Market Value. Not being apprised of all the specifics of the transaction I have made certain assumptions. It is my opinion that the Fair Market Value on the open market of a 9,672 s. f. site would be \$967,000.00, if sold by the City as a buildable parcel.

The Open Space Zone would require a reduction in value because of the restrictions placed on the site. The value in my estimation would be \$629,000.00 if sold. The Resolution states that the site will be leased to RIPTA. Given the lease option and retention of the site in City ownership, I arrived at a yearly rental of \$125,736.00 or \$10,500.00 per month based on the open space designation. Should RIPTA get the site at a value less than recommended the City should ask for a percentage of the actual rental stream produced by the occupants of the site.

The City Plan Commission at its regular meeting on Tuesday, June 15, 1999 reviewed and evaluated the communication of the Committee on Public Works dated May 17, 1999 requesting the Commission's recommendation on the proposed abandonment of a portion of Kennedy Plaza, the West Approach Road, and a portion of the East Approach Road. The Commission voted to recommend that the Committee on Public Works approve the petition to abandon the aforesaid public rights-of-way (see attached letter from Deller to Clarkin).

The Committee approved the abandonment of the East and West Approaches, but took no action on the Kennedy Plaza petition because a proper map describing the portion of right-of-way had not been prepared. Superintendent of Parks Nancy Derrig has resubmitted the petition for Kennedy Plaza. The area to be abandoned and the reason for abandonment have not changed. We therefore request that you reconsider the Commission's original recommendation to approve the petition to abandon the portion of Kennedy Plaza.

The City Plan Commission at its regular meeting on Tuesday, June 15, 1999, reviewed and evaluated the request from the Committee on Public Works on the petition to abandon a portion of Kennedy Plaza surrounding Lot 31 on Assessor's Plat 20, to accommodate a new RIPTA Intermodal Transit Center. Additionally, the petition requests the abandonment of the West Approach Road and portion of the East Approach Road with remaining unused right-of-way that was incorporated into the parcel of the Fleet Skating Center.



Whereas the City intends to enlarge AP 20, Lot 31 to accommodate a new and expanded transportation bus terminal that will be leased to the Rhode Island Public Transit Authority (RIPTA) by the Board of Park Commissioners, and

Whereas said AP 20, Lot 31 is not sufficient to accommodate such a terminal,

The Board of Park Commissioners hereby requests that a portion of the Kennedy Plaza right-of-way be abandoned by the Honorable City Council in accordance with the dimensions shown on the attached map.
