COUNCIL PRESIDENT

COUNCIL PRESIDENT FARGNOLI directs the Clerk to Call the Roll.

A legal opinion is requested of City Solicitor Glantz by Council President Fagnoli due to the lack of a quorum.

City Solicitor Glantz states Warrants were sent out for a Special Meeting and hand delivered by the City Sergeant.

Under Section 3.14 of the City Charter it is indicated that when a less number of the members of the City Council than a quorum is pres-

ent, they may adjourn from time to time to compel the attendance of the absent members.

Under the Rules of the City Council Number 5, the Council President shall take the Chair at the hour designated for the meeting of the City Council and call the members to order.

If there is less number of the Members of the City Council than a quorum, they may adjourn from time to time to compel the attendance of the absent members in such manner and under such penalties as may be prescribed by Ordinance.
