WHEREAS, Council President Rachel M. Miller, pursuant to Section 406 of the Providence Home Rule Charter of 1980, as amended and Rule 3 of the Rules of the City Council, requested the City Clerk, in writing, to Call a Special Meeting of the City Council to be held on Thursday, June 27, 2024 at 5:15 o'clock P.M., in the City Council Chamber, Third Floor, City Hall for the purpose of Enacting the following:

An Ordinance Providing for the Assessment and Collection of 2024 Taxes in a sum not less than Three Hundred Eighty One Million Twenty-Six Thousand Seven Hundred Twelve Dollars (\$381,026,712) and not more than Three Hundred Ninety-Six Million Two Hundred Twenty-One Thousand Four Hundred Three Dollars (\$396,221,403), being One Hundred Percent (100%) of the 2024-2025 Fiscal Year Tax Collections, Amending Section 21-182 of the Code of Ordinances to set the rates for Fiscal Year 2024-2025 and Amending Section 21-126 of the Code of Ordinances to set the Exemptions for Fiscal Year 2024-2025.

An Ordinance in Amendment of Chapter 2023-12, No. 294, Approved June 26, 2023 of the Ordinances of the City of Providence, making an Appropriation of Five Hundred Eighty-Three Million Two Hundred Thirteen Thousand Two Hundred Eleven Dollars and No Cents (\$583,213,211), for the Fiscal Year Ending June 30, 2024.

An Ordinance Establishing a Compensation Plan for the City of Providence and Repealing Ordinance Chapter 2023-13, No. 295, Approved June 23, 2023, As Amended.

An Ordinance Establishing the Classes of Positions, the Maximum Number of Employees, and the Number of Employees in Certain Classes in the City Departments and Repealing Ordinance Chapter 2023-14, No. 296, Approved June 26, 2023, As Amended.
