An Ordinance in Amendment of Chapter 16, Article IV of the Code of Ordinances of the City of Providence, Entitled: "Security Alarm Systems."


An Ordinance Relating to Article IV, Chapter 17, Section 17-192(F) of the Code of Ordinances. (Disability Waiver Request)


