## CHAPTER 1972-40

No. 253 **AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE, CHAPTER 1971-38 APPROVED JUNE 23, 1971, BY APPROPRIATING THE SUM OF SIXTEEN THOUSAND (\$16,000) DOLLARS TO BOARD OF CANVASSERS, ITEM 1, TO BE USED FOR UNBUDGETED COSTS TO MAY 23, 1972, PRESIDENTIAL PREFERENCE PRIMARY.

Approved June 23, 1972

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1971-38 of the Ordinances of the City of Providence, as approved June 23, 1971 entitled: "An Ordinance Making Appropriation of \$71,942,933.24 for the Support of the City Government for the Fiscal Year Beginning July 1, 1971 and Ending June 30, 1972", as amended, is hereby further amended by appropriating the sum of Sixteen Thousand (\$16,000) Dollars to BOARD of CANVASSERS, ITEM 1.

SECTION 2. The said sum of Sixteen Thousand (\$16,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer Sixteen Thousand (\$16,000) Dollars from the Reserve for Extraordinary Expenditure Account to the Receipt Account.

SECTION 3. The estimated receipts from the Reserve for Extraordinary Expenditures Account are hereby increased by Sixteen Thousand (\$16,000) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.
