AMENDING THE APPROPRIATION ORDINANCE,

CHAPTER 1222, BY TRANSFERRING THE SUM OF THIRTY THOUSAND (\$30,000)

DOLLARS TO SEWAGE DISPOSAL SECTION, ITEM 1.

Approved May 22, 1959

Be it ordained by the City of Providence:

SECTION 1. Chapter 1222 of the Ordinances of the City of Providence as approved September 19, 1958, entitled: "An Ordinance Making Appropriation of \$36,888,118.22 for the Support of the City Government for the Fiscal Year Ending September 30, 1959", as amended, is hereby further amended by transferring the sum of Thirty Thousand (\$30,000) Dollars to the appropriation contained therein for SEWAGE DISPOSAL SECTION, ITEM 1.

SECTION 2. The said sum of Thirty Thousand (\$30,000) Dollars shall be obtained by transferring a like amount from Snow Removal Section, Item 0.

SECTION 3. This Ordinance shall take effect upon its passage.

AMENDING THE APPROPRIATION ORDINANCE,

CHAPTER 1222, BY APPROPRIATING THE SUM OF FORTY-FIVE THOUSAND (\$45,000) DOLLARS TO SEWAGE DISPOSAL SECTION, ITEM 1, and FORTY-FIVE THOUSAND (\$45,000) DOLLARS to ITEM 2.

Approved May 22, 1959

Be it ordained by the City of Providence:

SECTION 1. Chapter 1222 of the Ordinances of the City of Providence as approved September 19, 1958, entitled: "An Ordinance Making Appropriation of \$36,888,118.22 for the Support of the City Government for the Fiscal Year Ending September 30, 1959", as amended, is hereby further amended by appropriating the sum of Forty-Five Thousand (\$45,000) Dollars to SEWAGE DISPOSAL SECTION, ITEM 1 and Forty-Five Thousand (\$45,000) Dollars to ITEM 2.

SECTION 2. The said sum of Ninety Thousand (\$90,000) Dollars as thus added and appropriated shall be obtained by authorizing and directing the City Controller and City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3. The estimated receipts from Reserve for Extraordinary Expenditures are hereby increased by Ninety Thousand (\$90,000) Dollars.

SECTION 4. This Ordinance shall take effect upon its passage.

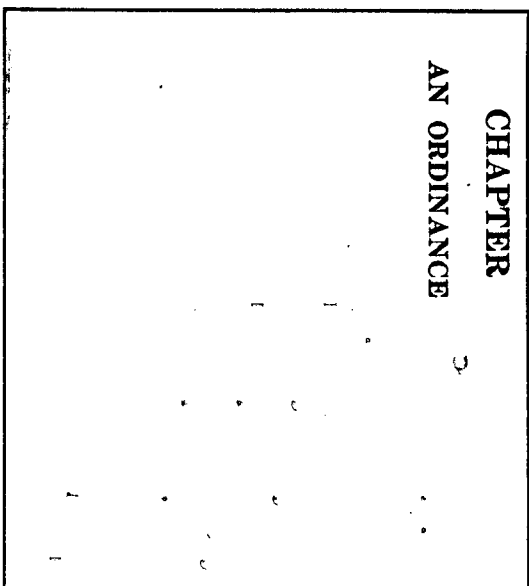
