Dear Mayor Cianci:

After the usual nominating process concluded this year, you requested that the Providence School Board Nominating Commission consider two candidates who had not been through the process and determine whether they were qualified for the Providence School Board. As you know, the Commission held a special public forum for the two candidates, Leonard Lopes and Makna Men, at Central High School on March 6, 2002. At the forum, each candidate made an opening statement and responded to a question posed by the League of Women Voters before the forum was halted by protests. The Commission then held interviews of the two candidates on March 27. Based on both the public forum and the interviews, the Nominating Commission has concluded that each of these candidates is qualified to be a member of the Providence School Board.

The deviation from past practice in this year's process has generated great public outcry and has caused a heated debate among many citizens about how best to attract and select School Board members. As you know, the Commission and the five nonprofit organizations that sponsor it conducted a study in 2001 of our School Board nomination process and that of other appointed School Boards around the country. We did the study to determine how to improve and strengthen our system. We were convinced then and remain convinced that the appointment of excellent people to lead the School Board is a key component of reforming our schools. And we all share the view that the process of selecting those leaders can be improved.

All members of the Nominating Commission urge you to seize the opportunity offered

by the current public passion around the School Board and the thoughtful analysis in our 2001 report. We ask that a review of the selection process be conducted and reforms to improve the process be put in place before the fall 2002 nominating process begins. We will be glad to assist in considering these important issues.

Finally, we recognize that many urgent matters face the City. However, we respectfully request that the process of selecting School Board members be made a priority. As volunteers whose energy and commitment to improving schools is as strong as ever, we will nonetheless decline to participate in this year's nominating process unless a review and reform of the process has been undertaken.

We look forward to continuing to build better education for the students of the City of Providence.






