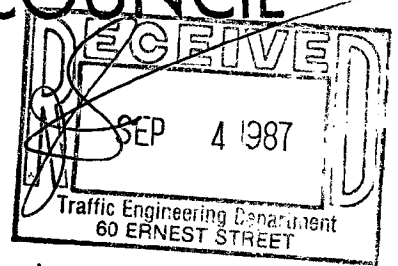

Disposition:

It is recommended that this practice not be allowed. Parking space on-street is in the public domain and is not for merchants such that they may control spaces in front of their stores. Further, I believe this practice would require the abandonment of portions of the public right-of-way and also, it would present legal liabilities for both merchants and the city government.

Finally, even if the request were done in a legal manner- which is questionable- merchants should not be allowed to control curbside parking; the result would be merchants and their employees parking in said spaces rather than customers and clientele of adjacent establishments.

The request is denied.

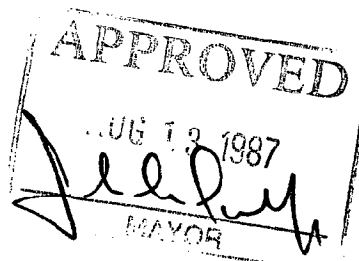
