We have completed our investigation of your request for a study of traffic conditions at the intersection of Metropolitan Road, Standish Avenue and Rialto Street.

Our volume study showed very low volumes of traffic at this location. In addition our accident records show only one reported accident since 1950. Since this location is adjacent to the Mount Pleasant High School Stadium, we feel that the only time traffic control is necessary is during functions at the stadium. However, during these times, the necessary control is furnished by police officers.
