

CHAPTER 184C

No. 217 AN ORDINANCE AUTHORIZING THE CITY COUNCIL TO ESTABLISH THE FOLLOWING FEES FOR THE ISSUANCE OF LICENSES BY THE BUREAU OF LICENSES OF THE CITY OF PROVIDENCE:

Approved March 20, 1967

Be it ordained by the City of Providence:

SECTION 1. Fees:

- A. Shooting galleries TEN (\$10) DOLLARS per day
B. Show and dance TWO (\$2) DOLLARS per day
C. Athletic exhibitions on Sundays:
Amateur - ONE (\$1) DOLLAR per day
Professional - TEN (\$10) DOLLARS per day
Athletic exhibitions on week days:
Amateur or professional TWO (\$2) DOLLARS per day
D. Motion pictures TWO (\$2) DOLLARS per day; Sundays FIVE (\$5) DOLLARS per day
E. Circus, rodeo, closed-circuit television, traveling shows, special events and other shows, performances and exhibitions, the fee shall be determined by the Bureau of Licenses upon application, and shall not exceed the sum of ONE HUNDRED (\$100) DOLLARS.

SECTION 2. Charges:

- A. All charges and costs with respect to reviewing circuses, rodeos, traveling shows, special events, and other shows, performances and exhibitions, including motion pictures, shall be borne by the applicant.

SECTION 3. This ordinance shall take effect upon its passage, and all other ordinances inconsistent herewith are hereby repealed.

RESOLUTION EXEMPTING FROM TAXATION OFF-STREET PARKING STRUCTURE TO BE SITUATED ON THAT PARCEL BOUNDED BY WASHINGTON, UNION, WORCESTER AND EDDY STREETS.

RESOLVED That any structure above or under the ground hereafter constructed and located in the City of Providence on that tract or parcel bounded by Washington, Union, Worcester and Eddy Streets containing approximately 36,184 square feet of land and designated as lots 51, 54, 56, and 58 on Assessors Plat 20 of the City Assessor of the City of Providence, and used by the public for parking of automobiles off the street or highway shall be exempt from taxation for a period of twelve (12) years beginning December 31, 1967, provided that the construction of such structure results in at least a two hundred (200%) per cent increase in the parking capacity of the premises as they existed prior to erection of such structure and provided further that the exemption shall be limited to that portion of the structure exclusively used for or devoted to the parking of automobiles and vehicles of that nature. The exemption granted herein shall be for such structure owned by National Garages of Rhode Island, Inc., its successors and assigns.

WHEREAS, there are presently located in the City of Providence certain structures which are in a dilapidated and deteriorated condition; and

WHEREAS, the City of Providence is vitally interested in the preservation and rehabilitation of neighborhoods throughout the City; and

WHEREAS, the demolition of certain of these structures will serve to promote the preservation and rehabilitation of these neighborhoods; and

WHEREAS, the owners of certain of these dilapidated and deteriorated structures are willing to convey title to these structures and to the land upon which they are located to the City of Providence without cost to the City; and

WHEREAS, by the acceptance of these deeds, the City of Providence will be enabled to demolish these structures with funds previously appropriated,

NOW, THEREFORE, BE IT RESOLVED, that the City of Providence hereby accepts deeds in fee simple to the land and buildings hereinafter described from the owners thereof:

1. Land and buildings located on the easterly side of Prairie Avenue, designated as Lot No. 119 on that plat entitled "Plat of land belonging when platted to Henry Holden of Providence, R. I. Run out by S.B. Cushing A. D. 1848" which plat was recorded in the Office of the Recorder of Deeds of the City of Providence in Plat Book 9 at Page 24 and (Copy) on Plat Card 251, conveyed to the City of Providence by Arnold I. Elman and Norman A. Elman.

2. Land and buildings located on the southerly side of Dudley Street in the City of Providence bounded and described as follows:

Beginning at a point in the southerly line of said Dudley Street, said point of beginning being 190.57 feet more or less easterly from the southeasterly corner of Dudley Street and Friendship Street and the said point being also at the north-easterly corner of land now or lately of Helena B. Meenan, thence running easterly bounded northerly by said Dudley Street a distance of 50.15 feet more or less to a point; thence turning and running southerly bounded easterly by land now or lately of Sydney Richman et al a distance of 137.69 feet more or less to a point; thence turning and running westerly, bounded southerly in part by land now or lately of Arthur D. Drury et al. and in part by land now or lately of Leo Feeley a distance of 50.15 feet more or less to a point; thence turning and running northerly bounded westerly in part by said Feeley land and in part by land now or lately of said Helena B.
