CLINICAL PSYCHOLOGIST

CLASS TITLE: Clinical Psychologist

CLASS DEFINITION:

GENERAL STATEMENT OF DUTIES: Through the use of psychological principles and techniques to assist a Psychiatrist in the study of problems presented by patients in a mental hygiene clinic; and to do related work as required.

SUPERVISION RECEIVED: Works under the supervision of a Psychiatrist from whom general or specific instructions are received; work is reviewed for technical competence and conformance to given instructions.

SUPERVISION EXERCISED: Plans, supervises and reviews the work of Psychometrists and, as required, clerical assistants for adequate and efficient work performance.

EXAMPLES OF DUTIES:

Through the use of psychological principles and techniques to assist a Psychiatrist in the study of problems presented by patients in a mental hygiene clinic; to administer, score and interpret a wide variety of tests, including projective techniques such as the Rorschach and Thematic Apperception tests; to determine the capacities, interests and abilities and other personality traits of the patient; to supervise the work of Psychometrists rendering psychological testing services for general use or in a clinic; to participate in conferences with a Psychiatrist and a Psychiatric Social Worker in order to study and evaluate all the evidence presented and to plan the treatment program for the individual; to assist in the preparation of informational material relative to the rendering of psychological services for dissemination to the public; and to do related work as required.

MINIMUM QUALIFICATIONS:

Experience such as may have been gained through: employment as a staff psychologist in a clinic or hospital utilizing the coordinated services of a psychiatrist, a psychologist, and a psychiatric social worker; or employment involving the application of psychological principles and techniques, and projective techniques, under the supervision of or in consultation with a qualified psychiatrist attached to any organizations whose functions include coordinated aid to patients requiring mental hygiene;

Training such as may have been gained through: graduation from a college of recognized standing and attainment of a master's degree in psychology with major emphasis in clinical and abnormal psychology, including courses with laboratory practice in psychometry.

CHAPTER 666, BY ADDING THE SUM OF ONE THOUSAND FIVE HUNDRED TWENTY SIX DOLLARS AND TWENTY-FIVE CENTS (\$1,526.25) TO THE APPROPRIATION CONTAINED THEREIN FOR RECORDER OF DEEDS, ITEM O.

Be it ordained by the City of Providence:

SECTION 1: Chapter 666 of the Ordinances of the City of Providence as approved September 22, 1952, and entitled: "An Ordinance Making Appropriation of \$28,328,060.70 for the Support of the City Government for the Fiscal Year Ending September 30, 1953", as amended, is hereby further amended by adding the sum of One Thousand Five Hundred Twenty Six Dollars and Twenty-Five Cents (\$1,526.25) to the appropriation contained therein for RECORDER OF DEEDS, ITEM O.

SECTION 2: The said sum of One Thousand Five Hundred Twenty Six Dollars and Twenty-Five Cents (\$1,526.25) as thus added and appropriated shall be obtained by authorizing and directing the City Controller and the City Treasurer to transfer a like amount from the Reserve for Extraordinary Expenditures Account to the Receipt Account.

SECTION 3: The Estimated Receipts from Reserve for Extraordinary Expenditures is hereby increased by One Thousand Five Hundred Twenty Six Dollars and Twenty-Five Cents (\$1,526.25).

SECTION 1. Section 127 of Chapter 2 of the Revised Ordinances of the City of Providence, 1946, entitled "Administration" is hereby amended to read as follows:

"Sec. 127. Fees and Certificates.

"The City weigher shall be entitled to demand and receive from the owner or person in charge of the articles weighed by him the sum of twenty-five cents for each load or vehicle weighed by him, and such owner or person shall be entitled to receive such reasonable number of certificates of weight as he may require."

Dear Sir:

In a recent Survey conducted by the Department of
Weights & Measures to determine the fees charged by
other Cities for weighing on city scales we have the following
following to report.

Worcester 25 cents to 1.00
Revere 25 cents per weighing
Waltham 25 and 50 cents
Medford 25 cents per Weighing
Newport 25 cents per weighing

I am sending this report to you in anticipation
of the introduction in the City Council of an amend-
ment of an existing ordinance to permit this depart-
ment to increase the fees for weighing at the City
Scales from 10 cents to 25 and 50 cents per weighing.

This schedule is in line with the fees charged in
several New England Cities.
