No. 466 AN ORDINANCE AMENDING ORDINANCE 2021-25, NO. 341, ADOPTING THE AMERICAN RESCUE PLAN ACT GRANT BUDGET FOR THE PERIOD OF APRIL 2, 2021 THROUGH SEPTEMBER 30, 2021, APPROVED JULY 16, 2021

Be it ordained by the City of Providence:

Section 1 - The Budget for April 29, 2021 - December 31, 2024 American Rescue Plan Act (ARPA) funding is adopted as follows:


