SECTION II: This Ordinance shall take effect upon its passage.

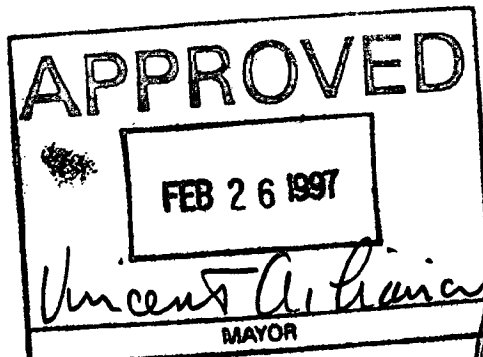
