RESOLUTION OF THE CITY COUNCIL

Approved November 13, 1986

RESOLUTION AUTHORIZING THE CITY TO EXCHANGE CERTAIN UNUSED AND OBSOLETE WEAPONS OWNED BY THE CITY FOR NEW WEAPONS AS REQUESTED BY THE POLICE DEPARTMENT.

WHEREAS, the Police Department, City of Providence owns certain unused and obsolete weapons, described as follows:

Colt Officers Model 6" revolvers, Serial Numbers 8813, 8445, 8512, 8706, 8877.

Smith & Wesson 6" Target Revolvers, Serial Numbers 644402, 644411, 644401, 636031, 644408, 644417.

Remington Model 870 12ga. shotguns, Serial Numbers 1003053v, 1076425v, 1030133v, 1194295v, 1089256v, 1072570v, 1072574v.

Beretta 7.65cal. pistol, Serial Number 520420.

Mossberg Model 500 12ga. shotgun, Serial Number H895268.

Winchester Model 97 12ga. shotgun, Serial Number 866080.

Smith & Wesson M-76 Submachine Guns, Serial Numbers U5085, U4965.

Ruger AC5.56 Mini-14's, Serial Numbers 191-05893, 191-05894, 191-05895, 191-05896, 191-05897; and

WHEREAS, the Police Department desires to acquire the following weapons:

Quantity 2, H & K Mod. MP5 Kay-w/3 shot burst

Quantity 3, H & K Mod. MP5 A-3

Quantity 1, H & K Mod 93S Shiper Rifle w/adj. buttstock scope mount, bipbd and set triffers; and

WHEREAS, the Police Department wishes to exchange its unused and obsolete weapons for the weapons it desires to acquire; and

WHEREAS, Quick Arms & Supply Company, of Johnston, Rhode Island is prepared to accept such weapons in exchange for the weapons desired to be acquired by the Police Department; and

WHEREAS, the City Assessor, pursuant to the Providence Home Rule Charter, Art. IV, acquisition and disposal of property, §416(7), has made an appraisal of all property included in the exchange and has determined that the value of the property to be received by the City equals or exceeds the value of the property to be disposed of by the City.

NOW, THEREFORE, BE IT RESOLVED, that the Chief of Police, or his designee, is hereby authorized and empowered to cause the exchange of the City's unused and obsolete weapons, as heretofore described, for the weapons which it desires to acquire, as heretofore described, with Quick Arms & Supply Company.


Dear Ms. Mendonca:

Re: Request by Police Department to Exchange Weapons

Dear Mr. Pisaturo:

By your letter of July 24, 1986, I was requested to review the proposal from the Police Department to trade-in unused and obsolete weapons for five (5) new weapons.

In conversations with representatives of the Police Department and local arms dealers, it became apparent that only one local vendor is able to complete such transaction due to the special licensing requirements to deal in machine guns.

The local vendor--Quick Arms & Supply Co., 708 East Avenue, Warwick, Rhode Island, has proposed in its quotation of June 9, 1986, to accept unused and obsolete weapons in return for new weapons and granting the department an additional credit toward future purchases.

I have met with Detective Joseph Schichilone, the department's Armorer, and viewed the weapons in question, and am in agreement with him and other representatives of the department, that the value of the property to be received by the City equals or exceeds the value of the property to be disposed of in accordance with provisions of the City's home-rule charter Section 416(7).

I am therefore recommending that the department be allowed to pursue the trade-in of the subject property.

Dear Mr. Littler:

Reference is made to my letter to you dated July 24, 1986, when I submitted a list of weapons together with an appraisal thereof made by a commercial gun shop. As you know the Charter [Section 416 (7).] provides that personal property owned by the City cannot be sold or transferred until the City Assessor makes an appraisal of the value thereof. You have indicated to me that neither you nor your staff have the expertise to give such an appraisal for these weapons.

The Police Department feels that it will be beneficial and valuable to effectuate such a transfer; and therefore, I must repeat my request that you cause to have such an appraisal made in accordance with the Charter. This may entail engaging another licensed commercial gun shop to provide such an evaluation. Perhaps the City Solicitor may further advise you as to the particular procedure that should be followed in this matter.




