It is requested that the Board of Contract and Supply authorize payment to Mythics, a sole source, in an amount not to exceed \$97,965.00 for Oracle database licensing fees.

It was recently brought to PWSB's attention that it has been out of compliance with its Oracle licensing fees for nearly a decade. An initial estimated cost of compliance was \$470,000.00 for one-time licensing fee, an estimated \$90,000.00 annual support contract and a possible audit by Oracle going back nearly a decade. After negotiations with Oracle the cost was reduced to a \$80,000.00 onetime licensing fee, a \$20,000.00 annual support contract and no retroactive audit if payment is made prior to December 31, 2014.


The use of the Oracle database is essential to the daily operations of the organization. PWSB currently uses Oracle database for its billing, inventory, work orders and GIS systems.

In order to provide GSA pricing Oracle has referred us to its Platinum partner, Mythics, the only known company that can offer an Oracle database Standard edition license at such greatly reduced pricing. Attached, please find Mythics quote.
