Dear Mr. Quigley:

The concern over "glue sniffing" has led city and town councils to initiate new legislation directed against the sale of this lethal chemical to minors. May I offer the following thoughts for your reflection before taking final action on hurried, new legislation.

Chapter 1, section 23-1-1 of our state laws outlines the general functioning of the State Department of Health. This section very clearly authorizes the state Director of Health, and your local Health Officer to take the type of action needed against the sale of this lethal glue to anyone, not just minors.

Chapter 28, section 21-28-2 (item 15) under title of "Uniform Narcotic Drug Act," further authorizes the state Director of Health to act against this killer glue. Also, section 21-28-32 details the penalties involved in offenses of this nature, especially as they relate to those under 21 years of age.

Chapter 24, section 23-24-1 further empowers city and town councils, in cooperation with the state Director of Health, to prohibit the sale and distribution of this noxious saleable material. Section 23-24-2, under Chapter 24, specifically authorizes the city or town council to enforce a decree of prohibition found under section 23-24-1. The laws are clear, enforceable and reasonable. Until science offers us an acceptable substitute, let us enforce our present, sensible laws.
