**AN ORDINANCE** AMENDING THE APPROPRIATION ORDINANCE CHAPTER 1983-30 APPROVED JULY 10, 1983, BY TRANSFERRING THE SUM OF TWENTY THOUSAND DOLLARS (\$20,000.00) FROM PUBLIC WORKS HIGHWAY (1-05-08-222) TO PUBLIC WORKS BRIDGE MAINTENANCE (1-05-09-266).

*Be it ordained by the City of Providence:*

SECTION 1. Chapter 1983-30 of the Ordinances of the City of Providence, as approved July 10, 1983, entitled: "An Ordinance making an Appropriation of One Hundred Sixty Nine Million, Seven Hundred Ninety Six Thousand, Two Hundred Forty Dollars and Ninety Six Cents (\$169,796,240.96) for the fiscal year ending June 30, 1984, as amended", is hereby further amended by transferring the sum of Twenty Thousand Dollars (\$20,000.00) from Public Works Highway (1-05-08-222) to Public Works Bridge Maintenance (1-05-09-266).

SECTION 2. This Ordinance shall take effect upon its passage.


