SECTION 1. Chapter 1982-42 of the Ordinances of the City of Providence, approved July 7, 1982, entitled: "An Ordinance Making an Appropriation Ordinance of One Hundred Fifty-Eight Million Two Hundred Thirty-Nine Thousand Eight Hundred Ten Dollars and Eighty-Four Cents (\$158,239,810.84) for the Fiscal Year ending June 30, 1983" is hereby amended by transferring the sum of Twelve Thousand (\$12,000.00) Dollars from Appropriation Reserve to the Department of Administration to the City Council.

SECTION 2. This Ordinance shall take effect upon its Passage.
