No. 203 **AN ORDINANCE** IN AMENDMENT OF ORDINANCE NO. 457, CHAPTER 1978-18, MAKING AN APPROPRIATION OF \$114,998,850.92 FOR THE SUPPORT OF THE CITY GOVERNMENT FOR THE FISCAL YEAR ENDING JUNE 30, 1979, AS AMENDED, APPROVED JULY 28, 1978.

Be it ordained by the City of Providence:

SECTION 1. Ordinance No. 457, Chapter 1978-18, making an appropriation of \$114,998,850.92 for the Support of the City Government for the Fiscal Year Ending June 30, 1979, is hereby amended to read as follows:
