

The Providence Redevelopment Agency, in accordance with the provisions of Paragraph 12 of Chapter 1044 of the Ordinances of the City of Providence, approved July 12, 1956, and Title 45, Chapter 32, Section 5 of the General Laws of Rhode Island, 1956, hereby reports concerning the proposed sale of real property within the Central-Classical Project No. R. I. R-2.

This Agency proposes to sell to Citizens Savings Bank, a Rhode Island corporation, two (2) parcels of land, approximately 10,200 square feet and 33,000 square feet of land, respectfully, for a total sale price of Fifty-One Thousand Seven Hundred (\$51,700.00) Dollars. These sites of land will be used by the redeveloper for the off-street parking of customers and employees. They will replace other land the redeveloper previously used for this purpose which was condemned by the Agency and which will be devoted to other uses in accordance with the official redevelopment plan for the project. As part of the consideration for the sale of these sites, Citizens Savings Bank has settled its claim against the Agency, arising out of the condemnation of its former property. The disposition of these sites to Citizens Savings Bank was contemplated in the redevelopment plan.



The New England Telephone and Telegraph Company investigated Resolution No. 391, approved July 9, 1962, and the following details are offered.

Massachusetts telephone users living in Seekonk and Rehoboth and referred to in the resolution are furnished telephone service from the East Providence (Edison 6) Central Office. For some years now those with private or two-party service have been paying added charges for local exchange service mileage. The Massachusetts Tariff - D.P.U. - Mass. - No. 10, Part III, General, Section 13, Page 1, Mileage Charges, states:

"Local exchange service mileage charges apply when the customer's location is outside the base rate area but within the exchange area."

The base rate area represents that portion of the exchange or zone within which exchange service, other than rural service, is offered at base rates for each grade of service without additional mileage charges. Customers living in rural sections, having one or two party service, are required to pay mileage charges as provided for in the Tariff (stated above). These charges are added to the monthly rate for the telephone service.

In the past, the Seekonk and Rehoboth areas have been mainly rural in character consisting of isolated and small communities without continuous development. However, building in recent years has changed these characteristics to a more densely developed type of community. A recent study indicated more urban type development now exists and that therefore, telephone service could be furnished at

base rates in most of Seekonk and also mileage charges could be reduced in the Rehoboth section.

Now, with the approval of the Massachusetts Department of Public Utilities, the base rate area has actually been extended and the mileage charges of many customers have been eliminated and in other cases reduced.

The City of Providence on the other hand is, and has been for many years, completely urban in type and therefore mileage charges have never applied to Providence municipal residents. The rate reduction, approved for Seekonk and Rehoboth customers, has no application to Providence Residents.

Gentlemen:

Council resolution of June 7, 1962 requests the Director of Public Welfare to study the feasibility of furnishing school meal tickets for children of parents receiving public assistance where such meals are available.

School lunches long have been recognized in public assistance feed standards and are considered in establishing family budgets. An allowance is made for children to purchase part or all of lunch in schools if a free lunch program is not in operation therein. This is done when (a) the distance is too great to allow going home for lunch, (b) school rules prohibit leaving school grounds for lunch or (c) there is no one at home to prepare lunch.

Most of the children of public assistance families are aided under the Aid to Dependent Children program which is financed in part by the federal government. There is a federal requirement that public assistance must be provided as a "money payment" and not in some restricted form. Thus cash payment is the prevailing form of assistance under the program.

I do not believe the furnishing of school meal tickets is feasible for the reasons presented herein.
