Whereas, the Director of the Rhode Island Department of Public Works has in effect endorsed the proposed extension of the Huntington Expressway as submitted to the public by his predecessor, and

Whereas, his Honor Mayor Walter H. Reynolds and the Providence City Council by Resolution 612 approved on December 22, 1961 did endorse a certain alternate proposed route for the extension of the Huntington Expressway to obviate the necessity of condemning properties of approximately 120 families and ten business establishments in the Elmwood Section of the City of Providence,

Now, Therefore, Be It Resolved, that the City Council by this resolution reaffirms its endorsement of the said alternate proposed route, being the so-called Austin Plan and expressly withholds its approval of that proposed extension of the Huntington Expressway previously designated as Line A and ~~an~~ ^{Dec} endorsed by the Director of Public Works for the State of Rhode Island in 1961.
