




MAINTENANCE AGREEMENT

BY AND BETWEEN THE

STATE OF RHODE ISLAND AND PROVIDENCE PLANTATIONS

AND THE

CITY OF PROVIDENCE, RHODE ISLAND

AGREEMENT entered into by and between the State of Rhode Island and Providence Plantation through its Department of Transportation (RIDOT) and the City of Providence, (hereinafter called the MUNICIPALITY).

WHEREAS: the STATE, in cooperation with the MUNICIPALITY, has selected the above-referenced Project in the City of Providence for construction.

WHEREAS: the MUNICIPALITY has requested the installation of certain facilities to the extent shown on the one (attached hereto as Exhibit "A" and made a part hereof) entitled "Crosswalk Construction, Westminister Street, Providence, Rhode Island" (hereinafter called the FACILITIES), as part of the Project.

NOW THEREFORE, the STATE and MUNICIPALITY hereby agree as follows:

SECTION I - GENERAL PROVISIONS

1. The STATE, through its Contractor, will construct the FACILITIES in accordance with Plans and Specifications for the Project.
2. The MUNICIPALITY will allow the STATE to enter onto its property for purposes of constructing the FACILITIES.

SECTION II - FUTURE MAINTENANCE


1. Upon completion of the construction of the FACILITIES, the MUNICIPALITY shall thereafter maintain said FACILITIES as constructed, at its own cost, with notice to and approval by the STATE. Traffic control must be in conformance with the requirements of the Manual of Uniform Traffic Control Devices, including all revisions.
2. The MUNICIPALITY shall indemnify and hold the STATE harmless from any and all injury or damage to persons or property arising out of the performance of work by the MUNICIPALITY or persons engaged by the MUNICIPALITY and shall carry adequate insurance to that end.


