Dear Councilman Payne:

Under date of June 8, we received an official memorandum from the City Clerk's Office in which was enclosed petitions covering the abandonments of Tallman Street, DiPippo Street, Honeyman Street and San Souci Street. We have reviewed our distribution plans and wish to report the following:

Tallman Street - No water works facilities whatsoever in this section of the highway to be abandoned so there are no objections on the part of this department.


Honeyman Street and Sans Souci Street - Both these highways are in the Weybosset Hill area and the Redevelopment Agency is planning to replace these mains with additional mains to suit the requirements of the Weybosset Hill Project.

DiPippo Street - This street has water facilities that have a depreciated value of \$1,641.02. This is broken down as follows:

Water mains	\$1,229.87
Gate Valve	.200.58
Services	<u>210.57</u>
Total	\$1,641.02

Before this street is abandoned, we respectfully request that you withhold action on this matter until the petitioner requesting the abandonment pays the City Collector \$1,641.02 covering the depreciated value of our facilities.

SUBJECT: Referral No. 1478 - ABANDONMENT OF DIPIPPA STREET

Gentlemen:

The subject referral received consideration by the City Plan Commission at a meeting held on Thursday, September 23, 1965.

This referral is a request to abandon DiPippo Street, from Killingly Street, northeast to its terminus, including its entire length.

On an inspection and photographic survey it was determined that the street in question is unpaved and uncurbed.

Reference is made to Referral No. 1449, of the Committee on Public Works dated June 25, 1965. At that time a request was made to abandon DiPippo Street from Killingly Street northeast to its terminus, including its entire length. The City Plan Commission offered no objection and the petition was referred back to Committee.

The present request is the same as described above. The street in question is in the center of an area that has recently been zoned C-2. A First National Store is to be erected on this site. The abandonment of this street will not affect any property other than the site for the new structure. Therefore,




