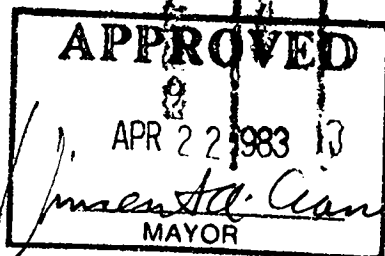
BE IT FURTHER RESOLVED, that the residents thereof be provided solely with public safety services, and the Police and Fire Departments of the City be notified of such.

It is my opinion that the attached resolution is within the powers delegated to the City Council by the Code of Ordinances. Section 23-1 states:

"The several streets in the city shall continue to be called and known by the names heretofore given to them unless and until they are altered by the city council".

Section 23-2 states in part:

"The City Council may order the buildings on any street to be numbered or may order any street to be renumbered, and the director of public works shall then require the number designated for each building to be affixed thereto or inscribed thereon...."
