Gentlemen:

The Authority acknowledges receipt of your Resolution No. 673 approved at the December 6, 1963 meeting of the City Council in which we have been requested to investigate and to study the necessity of establishing and operating an emergency dispensary and clinic or other medical facilities for senior citizens living in the Hartford Park development.

We regret to inform you that housing authorities are not allowed any funds to operate clinics or other auxiliary services. We may provide space and utilities but the provision of health services is considered by the Public Housing Administration to be the responsibility of the community in which public housing is established.

At Dexter Manor the Providence District Nursing Association operates a clinic, the funds for which have been provided by a federal grant for the past two years, to service the needs of the elderly but it is in operation only on the normal work day. Recently an extension of this service has been opened in facilities provided by the Authority in one building at Hartford Park. No housing authority money is expended in either of these developments for these services.




