No. 495 AN ORDINANCE IN AMENDMENT OF CHAPTER 27 OF THE ORDINANCES OF THE CITY OF PROVIDENCE ENTITLED "THE CITY OF PROVIDENCE ZONING ORDINANCE" APPROVED JUNE 27, 1994, AS AMENDED.

Approved NOVEMBER 8, 2007

Be it ordained by the City of Providence:

SECTION 1: Chapter 27 of the Ordinances of the City of Providence, entitled "The City of Providence Zoning Ordinance" approved June 27, 1994, as amended, is hereby further amended by changing the following text in Appendix A and Article III (the text to be removed is crossed out; the new text is underlined):

A. Appendix A is amended as follows:

- 26 Day Care Home – ~~Family Day Care Home~~ (See Definitions)
- 26.1 Day Care – Day Care Center, up to 8 people receiving day care (See Definitions)
- 26.2 Day Care – Day Care Center (see definitions), 79 to 12 people receiving day care Any other day care center which is not a family day care home
- 26.23 Day Care – Day Care Center (see definitions), more than 12 people receiving day care Any other day care center which is not a family day care home

B. Use Table 2.0 in Section 303 is amended as follows:

C. Footnote 4 to Use Table 2.0 in Section 303 is amended as follows:

- 4. Provided that if the day care facility is located in a dwelling unit, no more than fifty (50) percent of the GFA of the dwelling unit is devoted to day care and no more than one (1) person not living in the unit is employed by the day care facility.

SECTION 2. This Ordinance shall take effect upon passage and publication as prescribed by law.



Dear Councilman Solomon:

At a regular meeting of the City Plan Commission on June 19, 2007, and pursuant to Section 1100 of the City of Providence Zoning Ordinance Chapter 1994-24, No. 365, as amended, the Commission reviewed a proposal for the above-captioned amendment to the Ordinance. The Commission voted unanimously as described below to make certain findings of fact and to recommend that the proposed ordinance be approved.

Findings of Fact

Article XI of the Zoning Ordinance requires that in order for the CPC to make a positive recommendation on amendments to the Ordinance, it must demonstrate consistency with the Comprehensive Plan and with the purposes of zoning as listed in Section 100 of the Ordinance.

This proposal is consistent with the Comprehensive Plan and the Zoning Ordinance in that it consistently implements state law and protects public health, safety and welfare.


Recommendation
