


Tomas Avila replaces Laurence Flynn, who has resigned.

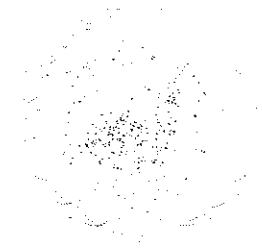
