Dear Mayor Paolino:

You have requested that this department provide you with a clarification as to the term of Joseph Mollicone to the Convention Center Authority.

Specifically you request that this office "clarify the continuance of service with regard to certain absences from regularly scheduled Convention Center Authority Meetings."

In order to answer this question, it is necessary to consult both the Providence Home Rule Charter and pertinent statutes of the Rhode Island General Laws. Section 1202 (a) of the Providence Home Rule Charter provides that if during a term of office a member is "... absent from five (5) consecutive regular meetings ... without the consent of the appointing authority ..., the office shall thereupon be declared vacant by the appointing authority and the vacancy shall be filled for the remainder of the term in the same manner as the original appointment."


R.I.G.L. 42-99-4 (d) (1), (Convention Center Authority Act), states in part that the "Chief Municipal Officer", where the facility is located "will each appoint four (4) Commissioners ..." for terms which are spelled out. Further, subsection (e) of the R.I.G.L. 42-99-4 provides that "...any commissioner may be removed by the appointing authority for misfeasance, malfeasance or willful neglect of duty." The section concludes by saying that "(A)ny vacancy resulting from ... other failure of a commissioner to continue to serve may be filled by the person given the power to make the original appointment."

It is the opinion of this office that when read together, both the charter provision and the state act permit you to do the following,

assuming that Mr. Mollicone has or did miss five (5) consecutive regular meetings without your consent:

- (a) declare his appointment to be vacant due to his absences; (Sec. 1202 of the Charter);
- (b) fill the vacancy by appointing a new commissioner for the balance of the term. (Sec.1202 of the Charter, and R.I.G.L. 42-99-4 (e)).

Thomas R. DiLuglio, of Johnston was born in Providence, November 25, 1931. Married to Loretta A. Migliaccio, they have five children. A graduate of Classical High School; Brown University, A.B.; and Boston University School of Law, LLB; he was named to championship Rhode Island New England & National College and amateur athletic teams. He is an attorney and a member and officer of the U.S. Supreme Court. He was named Town Solicitor, Chief Prosecutor, and acting Probate Judge for the Town of Johnston in 1970 and served through 1976. He was elected to the R.I. Senate in 1960 and reelected in 1962. In 1965 he was elected to serve as Chairman of the Legislative Committee of the Constitutional Convention until 1970. In 1958 he was elected to the Johnston Democratic Town Committee and presently serves as Chairman. He was elected Lieutenant Governor in 1976 and served in that capacity for eight years.

He was appointed by Governor Garrahy to coordinate the Job Training Partnership Act. He is President and founding member of the RI Chapter of the National Association for Alzheimer's Disease and Related Disorders; a member of the Corporation of Butler Hospital and Roger Williams College; member of the RI Bar Association; Metacomet Country Club; Phi Delta Theta International Fraternity; Orders Sons of Italy in America; Women's Center Advisory Board; RI Committee for the Humanities. He was a member of the Brown Club of RI; Classical Varsity Club; UCT; Senior Community Service Employment Program Advisory Board; Executive Board of the Federation of Public Programs in the Humanities; Chairman of the Intergovernmental Relations Council; Honorary Chairman 1979 Special Olympics; Chairman of Defense Civil Preparedness Advisory Council; in 1981 he was recognized by the Jewelry Institute of RI for his support in training of skilled worker for the jewelry industry; and in 1980 he founded and headed the Italian Disaster Relief which raised in excess of \$150,000 and over one million dollars in goods and equipment for victims of southern Italy's earthquake. He served as chairman of the National Conference of Lieutenant Governors. He has served on the Committee of Successions of the Office of Lt. Governor; Nominations Committee; Special Committee on Human Resources; Economic Development Committee and Government Relations Subcommittee. He is President of Cherry Hill Associates. He received an Honorary Doctor of Public Administration Degree from Roger Williams College. He serves as a panelist on "The Lively Experiment" which airs on Channel 36.
